

MANUFACTURER'S LIMITED WARRANTY

This Limited Warranty applies to all products ("Goods") manufactured and sold by LEO Takedown, LLC.

LIMITED WARRANTY AND DISCLAIMER. LEO Takedown, LLC ("**Manufacturer**") warrants that the Goods will substantially conform to Manufacturer's published specifications, if any exist; provided, any additions or any alteration to the upper receiver, barrel, frame or external dimensions of the AR-15, M4, M16 or other similar MILSPEC rifle itself or the Goods that is not specifically recommended in writing by Seller and is not performed by a certified or professionally trained gunsmith or armorer will void this warranty. This limited warranty extends only to you, the purchaser ("**You**" or "**Your**"). You must give Manufacturer written notice of the existence of each claim involving the Goods (whether based in contract, breach of warranty, negligence, strict liability, other tort or otherwise) within the earlier of thirty (30) days after receipt of the Goods forming the basis for the claim. If You timely notify Manufacturer of any nonconforming Goods, Manufacturer shall, in its sole discretion, (i) replace such nonconforming Goods with conforming Goods, or (ii) credit or refund the Price for such nonconforming Goods, together with any reasonable shipping and handling expenses incurred by You in connection therewith. You shall ship, at Your expense and risk of loss, the nonconforming Goods to Manufacturer's facility located at Rome, Georgia. If Manufacturer exercises its option to replace nonconforming Goods, Manufacturer shall, after receiving Your shipment of nonconforming Goods, return ship to You the replaced Goods. For purposes hereof, "**nonconforming Goods**" means only the following: the Goods do not substantially conform to Manufacturer's published specifications, if any, or the Good's label or packaging incorrectly identifies its contents. A failure by You to give such notice within the applicable time constraint will constitute an absolute and unconditional waiver of all such claims. EXCEPT AS STATED HEREIN, MANUFACTURER MAKES NO REPRESENTATION OR WARRANTY OF ANY KIND WITH RESPECT TO GOODS, EXPRESS OR IMPLIED, RESPECTING MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE. Any affirmation of fact or promises made by Manufacturer, or samples and/or pictures provided by Manufacturer shall not be deemed to create an express warranty that the Goods shall conform to such affirmation or promise or sample or picture. Any descriptions and samples with respect to Goods are not warranted by Manufacturer to be accurate or complete. THE PROCESSING OF ANY CLAIMS REGARDING MATERIALS AND WORKMANSHIP SHALL BE AT THE SOLE DISCRETION OF MANUFACTURER, WITH YOUR REMEDY, IF ANY, SOLELY BEING LIMITED TO REPLACEMENT OF THE GOODS OR A REFUND OF THE PURCHASE PRICE OF THE GOODS.

LIMITATION OF LIABILITY. The use and/or misuse of the Goods may result in serious personal injury, death, and/or property damage. The Goods are constructed to fit standard factory equipped AR-15, M4, M16 and similar MILSPEC rifles only. Additions or any alteration to the upper receiver, barrel, frame or external dimensions of the AR-15, M4, M16 or other similar MILSPEC rifle itself or the Goods that is not specifically recommended in writing by Seller may render the Goods unsafe and increase the risk of injury or death. Manufacturer shall not be responsible for any loss or injury resulting from defects or alleged defects in the Goods sold or from the subsequent use of the Goods by You or a third party. Your remedies set forth herein are exclusive. IN NO EVENT SHALL MANUFACTURER'S AGGREGATE LIABILITY ARISING OUT OF OR RELATED TO YOUR PURCHASE OF THE GOODS, WHETHER ARISING OUT OF OR RELATED TO BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, EXCEED THE PURCHASE PRICE PAID BY YOU FOR THE GOODS SOLD HEREUNDER. IN NO EVENT SHALL MANUFACTURER BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY LOSS OF USE, REVENUE OR PROFIT, OR FOR ANY CONSEQUENTIAL, INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES WHETHER ARISING OUT OF BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT MANUFACTURER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND NOTWITHSTANDING THE FAILURE OF ANY AGREED OR OTHER REMEDY OF ITS ESSENTIAL PURPOSE.

VENUE; JURISDICTION. This Limited Warranty and any disputes arising out of or related to this Limited Warranty shall be governed by and construed in accordance with the laws of the State of Georgia, without regard to the choice of law rules of any state. Any action seeking to enforce any provision of, or based on any matter arising out of or in connection with, this Limited Warranty or the Goods must be brought in any state court located in the County of Floyd, State of Georgia, or in the United States District Court, Northern District of Georgia, Rome Division.
